MEMBERS JUDGED SHOW AGREEMENT

I, _____, the undersigned Exhibitor and/or Owner of works of art to be displayed at the 29 Palms Art Gallery during the period _____ to _____, hereby agree to the following:

1. The Exhibitor assumes responsibility for delivery and pickup. Unclaimed work will be placed in a utility room and the Gallery assumes no responsibility for its well-being. Any work left ninety (90) days after notification by email or phone call shall become the property of the Gallery.
2. The Exhibitor shall provide proof of their current membership upon delivery of artwork for the Exhibition.
3. The Gallery assumes responsibility for arranging art works within the prerogatives of the Board of Directors.
4. The Member's room exhibitor agrees to pay \$30 for each piece (cash, check, card). Art on a pedestal is considered one piece. (Please note that pedestals are limited.) If your art work is 14" or smaller on the longest side, two pieces may qualify as one. Size limit is 48" wide and 60" high. You may have more than one entry.
5. If you sign up to docent or work the gift shop twice in May, you will get a discount of \$20 on one piece or a discount of \$10 for signing up once. This opportunity is on a first-come first-served basis and limited to no more than two sign-ups.
6. Agreement: The Twentynine Palms Artists' Guild, any member or agent or sponsor, will not be responsible for loss, theft, or damage of any kind to the work(s) of art submitted to the Guild and accepted for show. The Artist/ Owner is responsible for insurance.
7. The Exhibitor has read and agreed to the conditions stipulated in the Standing Rules of the Twentynine Palms Artists' Guild and understands the commission rate on sold artwork is 35%.
